Wholesale Discount Plan (C)

GUIDANCE NOTES FOR IPLC WHOLESALE DISCOUNT PLAN (C)

1. General Rules

- 1.1 Only full time use of IPLC Digital Data Service (DDS) duplex circuits at speed 64Kbps or above are qualified for the IPLC DDS Wholesale Discount Plan (C) (here below called "Plan C").
- 1.2 This plan is not applicable to IPLC circuits currently subscribed to other IPLC discount plans.
- 1.3 The Monthly Basic Rental of DS3, STM-1, STM-4, STM-4c, STM-16 and STM-64 is equal to the Monthly Basic Rental of E1 times 21, 63, 252, 252, 1008 and 4032 respectively.
- 1.4 The bandwidth volume and circuit quantity associated with IPLCs subscribed under this plan will not be taken into account for the determination of any discount levels in any other IPLC discount plans.
- 1.5 The offer of this plan will be subject to the availability of Capacity

2. Discounts

Additional discounts will be given subject to agreement between the Company and the Customer.

3. Short Term Lease

In the event that Customer wishes to subscribe Plan C by entering into a Minimum Commitment Period of less than 1 year, additional charge will be levied.

4. Up Front Payment

In the event that the Customer wishes to pay up-front, a discount factor will be applied as agreed between the Company and the Customer.

5. Customised Routing

In the event that the Customer requests for special routing arrangement, Customer must, if required by the Company pays any additional charges or all costs incurred by the Company in relation to provide the requested routing.

6. Cancellation Charge

In the event that the Customer cancels the Service before the expiry of the Minimum Commitment Period, the Customer shall be liable for payment of the cancellation charges as follows:

MCP of less than or equal to 1 year	100% of monthly Rental payable for the remaining unexpired term.
MCP of longer than 1 year	85% of monthly Rental payable for the remaining unexpired term.

7. Conditions of Service

This discount plan is made available by the Company to the Customer subject to the Company's General Conditions of Service and the Special Conditions of International Private Lease Circuit (IPLC) Service.
