FIXED TELECOMMUNICATION NETWORK SERVICES LICENCE
TELECOMMUNICATION ORDINANCE (Chapter 106)

In accordance with General Condition 20 of the Fixed Telecommunication Network Services Licence, Reach Networks Hong Kong Limited hereby publishes the following revisions to the tariffs, terms and conditions under which it provides the following telecommunication service.

FIXED TELECOMMUNICATION NETWORK SERVICES LICENCE
TELECOMMUNICATIONS ORDINANCE (Chapter 106)

In accordance with General Condition 20 of the Fixed Telecommunication Network Services Licence, Reach Networks Hong Kong Limited hereby publishes the following revisions to the tariffs, terms and conditions under which it provides the following telecommunication services.

International Telegram

International Telegram service will discontinue with effect from 1st January 2004.

International Telex

The following service is added to 'Clause 1 Service Description'.

“1.9 Tropical Cyclone Warning

Tropical Cyclone Warning service is a broadcast service to disseminate the tropical cyclone warnings issued by the Hong Kong Observatory. The message provides information on hoisting and lowering of typhoon signals, together with indications of the position, direction, magnitude and a 3-day forecast of the cyclone. Messages are delivered to subscribers via telex or facsimile as specified by subscribers.

- (a) Long-Range Option
24-hour dissemination of warning messages
- (b) Day-Time Option
Dissemination of warning messages from 8 a.m. to 6 p.m. only
- (c) Short-Range Option
24-hour dissemination of warning messages after typhoon signal No.1 is hoisted
- (d) Typhoon Signal Plus
Receives only the hoisting and lowering of typhoon signal plus one warning message daily in the afternoon schedule after typhoon signal No.1 is hoisted”

The following service charges are added to 'Clause 2 Charges'.

“2.8 Tropical Cyclone Warning

- (a) Long-Range Option
 - (i) Telex Option \$3 per minute (see Note 6)
 - (ii) Facsimile Option \$5,000 per annum (see Note 7)
- (b) Day-Time Option
 - (i) Telex Option \$3 per minute (see Note 6)
 - (ii) Facsimile Option \$2,500 per annum (see Note 7)
- (c) Short-Range Option
 - (i) Telex Option \$3 per minute (see Note 6)
 - (ii) Facsimile Option \$2,000 per annum (see Note 7)
- (d) Typhoon Signal Plus
 - (i) Telex Option \$333 per annum (see Note 7)
 - (ii) Facsimile Option \$500 per annum (see Note 7)”

Note 6 and 7 below are added to 'Notes'.

- “6. Charges are based on duration of the telex call for delivery of the warning message. Only successfully delivered messages will be charged.
- 7. On termination of the Tropical Cyclone Warning service, no annual subscription fees or part thereof will be refunded to the Customer.”
